Mark Faulk conversation with Morris Richards, DTCC

Morris Richards: Hello

Mark Faulk: Is this Morris Richards?

Richards: Yes

Faulk: This is Mark Faulk, I am the CEO of CMKM Diamonds, CMKX. What I am trying to do is just once and for all confirm a couple of conversations that several of our shareholders have had with you. I have written statements of conversations shareholders have had with and I just wanted to ask you if these were accurate. Would you mind if I run these by you, I have a couple of people who sent me information of conversations they have had with you and I wanted to either confirm those or not.

Richards: I keep getting deeper and deeper into this thing and I really don't want to get into this. I really don't want to be involved with this issue.

Faulk: I understand that. The only thing I would like for you to do if you would is this: Someone named Christopher Leonard spoke to you last week on January 23, and he said that he asked you, and this is a very simple question, he asked you "if you could confirm a conversation with Rod a few years back with regards to CMKM". He said: "I then asked Mr. Richards if it is true that he told Rod Gorman that money was collected on behalf of CMKM and it was supposed to be distributed and he did not know why it had not been released. He said that "Mr. Richards confirmed the conversation took place and said that it was true."

Richards: That is not true.

Faulk: That is not true? You did not have that conversation with Rod Gorman?

Richards: No, I did talk to the guy last week and he tried to get some information out of me and I said there's nothing I can tell him.

Faulk: You did not confirm that you spoke to Rod Gorman and you did not confirm that you said that money was collected on behalf of CMKM shareholders to Rod Gorman?

Richards: No. No.

Faulk: Have you confirmed that to anyone?

Richards: No, I have never told that to anybody.

Faulk: You have never told anyone that money was collected on behalf of....

Richards: No, no,

Faulk: Have you ever told anyone that money was supposed to be distributed to shareholders?

Richards: Nope.

Faulk: Okay. Well, I have four different people who have made that statement and swear that it's a very true statement.

Richards: No.

Faulk: Is it true that a court order came down and that you're not allowed to speak about this anymore?

Richards: I was told not to speak about it, there may not have been a court order but I was told not to say anything about it, because at that time there was a distribution that was done with CMKM Diamonds, there was a stock distribution that we did, and after that I was out of the whole situation.

Faulk: Are you speaking of the Entourage distribution or....

Richards: A stock distribution.

Faulk: A stock distribution. So you're not talking about a cash distribution.

Richards: No, no, no.

Faulk: Okay, well that answers one of my questions. Is there anybody there that I can speak with to kind of follow up on this, because as I said, I'm CEO of the company and we get a ton of rumors and occasionally they turn out to be true and many times they turn out not to be true, and I have to just trace them back so that they do not grow into.....

Richards: I understand. I never said anything to anybody.

Faulk: So the only thing that you spoke of had to do with....

Richards: ....was a distribution of the stock.

Faulk: A distribution of shares of stock and not a cash distribution.

Richards: Not a cash distribution. Right.

Faulk: Alright. Is there someone else there that I can speak to, like a superior or someone who can....

Richards: No. They're not with....they're not there anymore.

Faulk: Okay. Can you tell who it was that was in charge at that time?

Richards: uh.....now I forget.....uhhhhh.....the only person who I worked with back then was a lady at the transfer agent, and she worked with me. What was her name? I forgot her name.

Faulk: Was that Helen Bagley?

Richards: Yes, Helen.

Faulk: So you were dealing with the transfer agent with a stock distribution....

Richards: Right, right.

Faulk: ....and not a cash distribution whatsoever?

Richards: no.
